WAIT LIST:

Entries are limited to 32 dogs or what can be ran in
daylight hours. If entries fill up before the test
closing date, your entry will be placed on a waiting
list. Upon any scratches, waiting list entries will be
placed in the order they were received. Unplaced
entries on the waiting list will be refunded. Up to the
start of the hunt test, if the club is aware there are
dogs that will not participate, those vacancies can be
filled across all test levels using the entries on the
wait list in the order they were received. Refunds
shall be in full for scratched dogs--bitches coming in
season or a dog that has been injured, that have
been replaced. (Prior to refunding entry fees, the
club may require veterinary certification.)

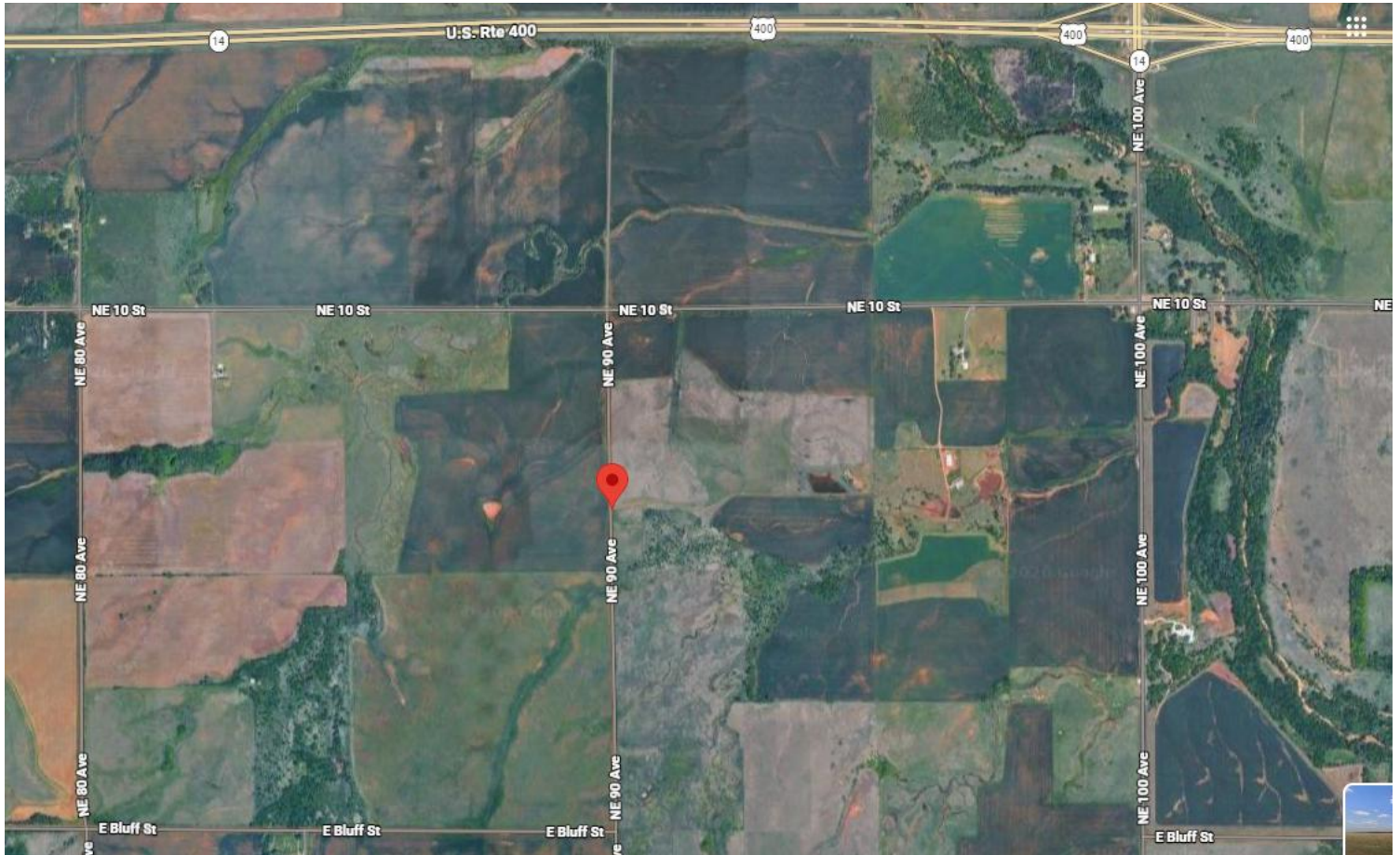
Directions to the Hunt Test Location:

Coming to Wichita from the South:

From HWY 35N take exit 42 to HWY 135N. Take exit 1C (left lane) to HWY 235N. Take exit 7 to Hwy 54/400 west. From the interchange go west approximately 29 miles to intersection with K14 HWY. Exit to the right then turn south on K14 (NE 100th Ave) go approximately 1/2 mile. Turn right (west) at first intersection (NE 10th St) and go 1 mile (NE 90th Ave). Turn south about 1/4 mile, grounds on left.

Coming to Wichita from the North:

From HWY 135S take exit 11B to get on HWY 235S/96W. Take exit 7 to HWY 54/400 west. From the interchange go west approximately 29 miles to intersection with K14 HWY. Exit to the right then turn south on K14 (NE 100th Ave) go approximately 1/2 mile. Turn right (west) at first intersection (NE 10th St) and go 1 mile (NE 90th Ave). Turn south about 1/4 mile, grounds on left.
