Please bring your own beverages and lawn chairs

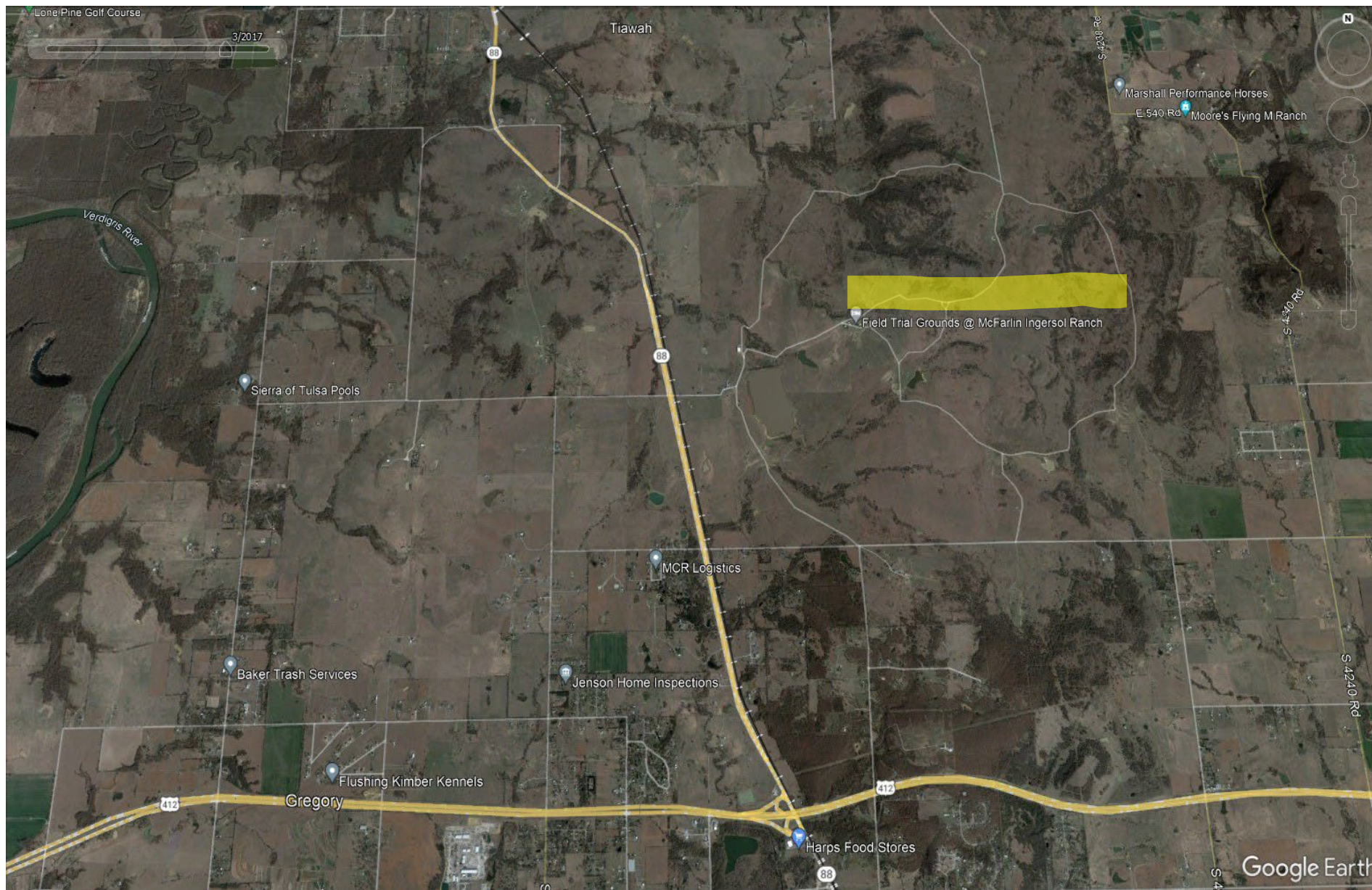
Running water for dogs and horses is available at the grounds.

Do not stake horses and dogs near the Club House see figure below.

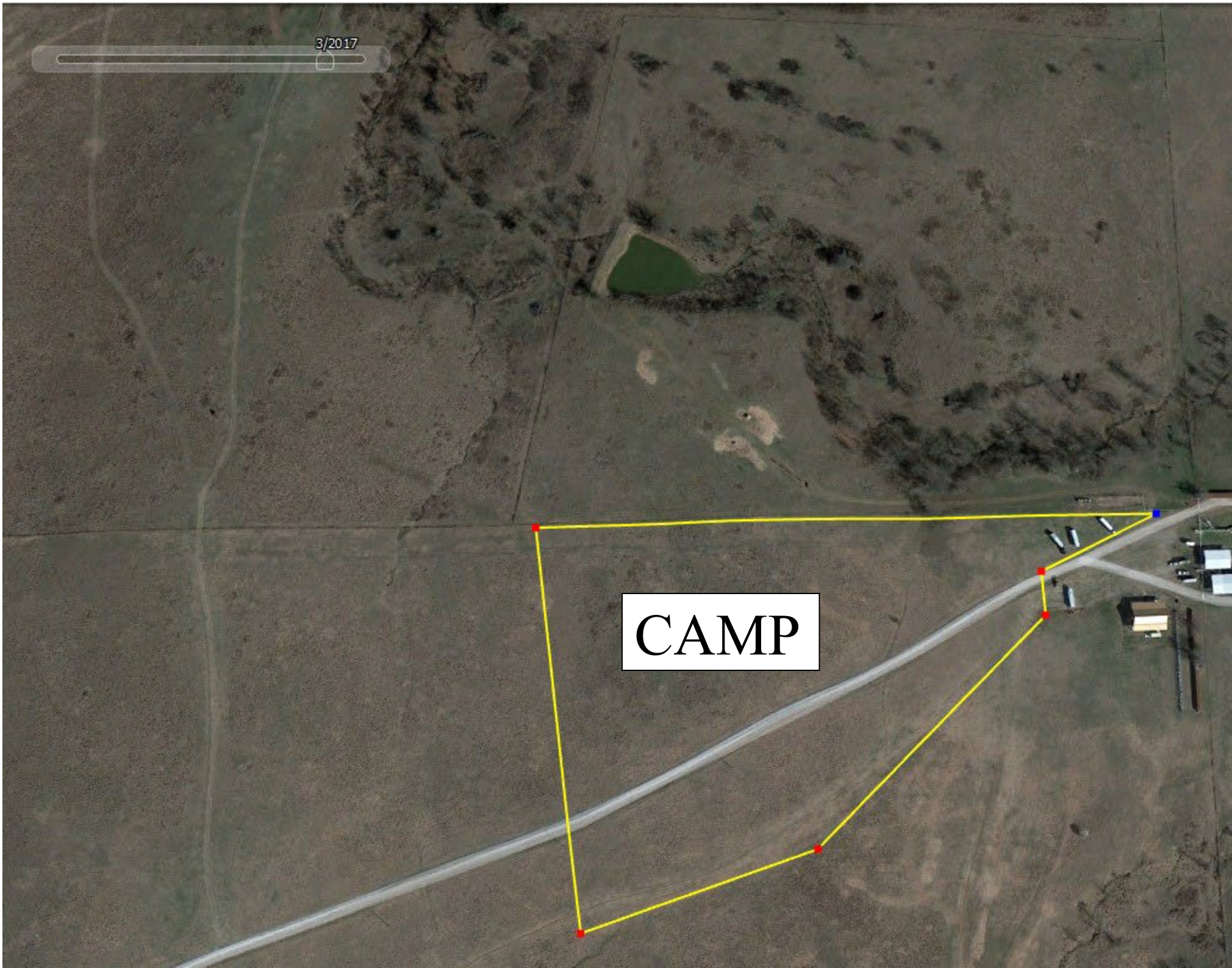
